**AMENDED SETTLEMENT SCHEDULING ORDER**

Before the Court is the parties’ Joint Motion to Extend Certain Settlement Approval Deadlines [Doc. 109] requesting that several deadlines set by the Court’s Settlement Scheduling Order [Doc. 108] be extended by two weeks. Given the short nature of the requested extension, the lack of any opposition to the request, and the fact that providing the requested extension will not disturb the deadlines for either the Final Approval Hearing or the filing of the Final Approval Brief, the Joint Motion is **GRANTED**. This Amended Settlement Scheduling Order **REPLACES** and **SUPPLANTS** the prior Settlement Scheduling Order [Doc. 108] entered in this case as to all unexpired deadlines and outstanding requirements. Unless a new date is provided by this Order, deadlines that expired prior to the entry of this Order remain expired.

1. Plaintiffs’ Motion for Preliminary Approval shall be submitted on or before **September 12, 2024**
2. Defendants’ CAFA Notice as required by 28 U.S.C. § 1715(b) shall be submitted on or before **September 20, 2024**.
3. Defendants shall provide their Class List Information to the Settlement Administrator on

or before **September 26, 2024**.

4. The Settlement Administrator shall send Notice to Class Members on or before **October 10, 2024**.
5. Any Motions for Attorneys' Fees, Expenses, and Service Awards shall be submitted on or before **November 4, 2024**.
6. The Opt-Out or Exclusion Deadline for Class Members shall be **November 25, 2024**.
7. Any Objections by Class Members shall be submitted on or before **November 25, 2024**.
8. The Final Approval Brief and Responses to any Objections shall be submitted on or before **December 3, 2024**.
9. The Final Approval Hearing will be held on **December 17, 2024, at 2:00 p.m. E.T.** at the United States Courthouse at 220 West Depot Street, Greeneville, Tennessee.
